### WHAT'S HAPPENED, WHAT'S COMING UP...

### NFCA has done a lot this year...

**Technical Code** – NFCA's participation at the International Code Council's Code Development Process has kept the structural fire-resistance concept front and center. We changed the terms Intumescent Mastic and Intumescent Coatings - yes two terms for the same thing – to Intumescent Fire-Resistive Materials (IFRM). Code officials commented, "This is not paint or coating, it's FIREPROOFING, with specific manufacturer's instructions and a listing that needs to be respected."

**Technical Standards** – A NFCA "Standard Practice for IFRM Finish" task group has been exchanging emails setting up for a virtual meeting in early '23. We've heard the call to define what finish level is expected for IFRM's, and NFCA Members will collaborate to get this done.

NFCA's Bill McHugh was appointed to UL/ULC's Standards Technical Panel for UL 263 and CAN/ULC-S101. We're honored to bring jobsite knowledge to the UL/ULC standards development process.

At ASTM, we work with our manufacturer partners to make the standards reflect real world project conditions.

**Technical Education** – We're retooling the Fireproofing Special Inspection education program, so it reflects today's requirements, and are adding a lot more pictures so the program comes alive. Look for work on the NFCA Education for Fireproofing Exams too as we review the program and add new content.

**Program** – NFCA's Program Committee met to recommend educational programs for the upcoming **NFCA Week of Learning** in Charlotte, NC, USA. Should be great.

**NFCA's Board of Directors** – Met in December to review 2022, and set some sights on 2023. We're Thankful for all the work the Board does to set strategic direction for NFCA.

### **SAFETY SECTION:**

The US Occupational Safety and Health Administration (OSHA) section 1910.134(c) is the requirement dealing with a *Respiratory protection program*. It might seem apparent that if a respirator is not required, the employer has no responsibility to make employees aware of the standard.

Not so! Section 1910.134(c) <u>Appendix D</u> as it relates to the voluntary use of dust masks and respirators does in fact set contractor employer's responsibility for making employees aware of the standard, and procedures for safe use of respiratory protection. Check out the what employers need to communicate, based on OSHA's standard, directed to the employee, below:

You should do the following:

- 1. Read and heed all instructions provided by the manufacturer on use, maintenance, cleaning and care, and warnings regarding the respirator's limitations.
- 2. Choose respirators certified for use to protect against the contaminant of concern. NIOSH, the National Institute for Occupational Safety and Health of the U.S. Department of Health and Human Services, certifies respirators. A label or statement of certification should appear on the respirator or respirator packaging. It will tell you what the respirator is designed for and how much it will protect you.
- 3. Do not wear your respirator into atmospheres containing contaminants which your respirator is not designed to protect against. For example, a respirator designed to filter dust particles will not protect you against gases, vapors, or very small solid particles of fumes or smoke.
- 4. Keep track of your respirator so that you do not mistakenly use someone else's respirator. [63 FR 1152, Jan. 8, 1998; 63 FR 20098, April 23, 1998]
