Learn about the Code requirements, which dictate the use of Standards, for structural fire protection and effective compartmentation.

Once the Building Codes specify Standards, understanding what the Standards evaluate is critical to proper 'Design, 'Installation, 'Inspection, and 'Maintaining Protection in new and existing buildings.

This session takes an in-depth look at the ASTM E814, UL 1479, ASTM E1966, UL 2079, ASTM E2307, ASTM E3037, ASTM E2786 Standards, and much more.

Navigating Fire Testing and Classification Requirements for Firestopping

This session looks at the rules from the Code which need to be considered before testing firestopping, like pipe penetrations and linear joint seals. The session also compares the general American and European firestopping Standards.

Then, the session looks at the European Fire Test Standards to determine what is and is not included in the scope of the Fire Test (ducts, dampers) and how these products are assessed using the EN 15882-5 and EN 1366-3 Fire Test Standards. Finally, the session covers EN 13501-2 and the advantages to testing with EN.

Passive Fire Protection (PFP) in the Built Environment - An Insurer's Perspective
Laxminarayan Nayak, Liva Group

Structures in the built environment are vulnerable to damage in severe fire conditions. The Passive Fire Protection (PFP) system is crucial in determining whether a situation can be managed or becomes catastrophic.

This conference presentation will focus on the resilience strategy and the integration of business and insurance-driven fire safety objectives. It will also cover the use of various passive fire protection system elements used in insurance risk assessment, loss modeling, and their potential impact on claims management.

Maintenance of PFP systems and emerging risks such as PV panels on rooftops will be addressed, as their role may seem passive but their impact during a fire can be significant. The importance of PFP, particularly in terms of insurance benefits, will be discussed, ultimately leading to the alignment of businesses with insurers' risk mitigation objectives and fostering a mutually beneficial relationship.

FCIA worked closely with UL to build the UL Qualified Firestop Contractor Program and FM Approvals for the FM 4991 Standard for the Approval of Firestop Contractors.

NFCA developed the NFCA Contractor Accreditation Program, which supports UL's Qualified SFRM Contractor Program.

The ASTM E2174 and ASTM E2393 Standards are the process documents that direct firestopping inspection.

The International Building Code, ASTM E605, and ASTM E736 provide the guidance to inspect SFRM Fireproofing; while the AWCI 12b is the industry standard which outlines the processes to inspect IFRM Fireproofing.

The International Fire Code, NFPA 101, NFPA 1, and UAE Fire and Life Safety Code of Practice all require that firestopping and fireproofing protection be maintained.

This session looks at the requirements for each.

FCIA Education for the FM & UL Firestop Exams

Bill McHugh, FCIA

The FM & UL Firestop Exams are based on FCIA's Firestop Manual of Practice (MOP), the FM & UL program guides, and systems selection and analysis. These exams are used for contractor personnel to become FM 4991 Approved Contractor and UL Qualified Contractor Program DRIs.

For Special Inspectors, passing the exam proves firestopping competency to the Authority Having Jurisdiction (AHJ), required by the IBC's Chapter 17. Passing an exam is also a requirement in IAS AC 291 for the Inspector to become a Responsible Person.

The FCIA Education for the FM & UL Firestop Exam education sessions help prepare individuals and support individual preparation for these rigorous exams, further strengthening and developing firestopping knowledge.

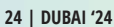
